RONNIE HAILS HIS PICTURE PERFECT WIN

A YEAR in the life of Ronnie O'Sullivan got the fairytale ending — but it won't be the last dance for the 'Rocket'. The 46-year-old is being hailed as the greatest player in history after equalling Stephen Hendry's record of seven world titles with an 18-3 win over Judd Trump at the Betfred World Championship, World No.1 O'Sullivan, the oldest Crucible champion, is not done yet — suggesting Hendry may only get to share the record for a year, and that he could play into his 50s and go for 10. "It's harder in an individual sport, definitely. I said to [sports psychiatrist] Steve Peters that I wished I was in a team sport. At least then you can take a week off or be rested for a bit. "You can have that relationship with your manager, where you can kind of pick and choose when to play. Pressure "In an individual sport you're kind of forced to play, even if you feel you don't want to. So it's tougher, but I chose this sport and there's not a lot I can do about it now. "I'm good with pressure, so having the crew around wasn't an issue. In some ways, it might have inspired me. "And things just seem to work out — so I'm not surprised that it ended like that.
